APPROVAL OF MINUTES

The minutes of the May 30, 2018 RACOA meeting were reviewed and approved.

VOTE NEW MEMBER

The committee unanimously voted to approve Dana Sercos as a new RACOA member. This vote will be taken to the CVCOG Executive Committee for final board approval.

TEXAS SILVER HAIRED LEGISLATURE (TSHL) REPORT

Member Sherry Hubbard provided an update on the Legislative report containing the ten highest voted Resolutions. The report went to print, and will be distributed to TSHL members at the Executive Meeting in Lubbock on July 21, 2018. On July 27, 2018 from lpm-4pm voluntary there is a TSHL

meeting in Austin to distribute Legislative report to 150 Representative offices, 37 Senatorial offices, and the Governor/Lieutenant Governor offices. Reminded the committee that there are still seats available for individuals interested in representing TSHL for the Concho Valley region. Member Wayne Merrill gave status update on Chairman Dolores Schwertner's referral for TSHL member. Still need to look at resolutions to be proposed that will help seniors that don't require funding or take away funds from the state.

AREA AGENCY ON AGING (AAA) DIRECTOR'S REPORT

Director Roberts provided updates on the following:

FY 18 Working Budget - Minor changes are still needed. The state's biggest concern is the EBI -Title D funds.

Stress Busting/EBI program updates -Units need to go up for this program. Efforts are being made to reach out to Concho and Crockett counties to begin classes in those counties. Chairman Dolores Schwertner spoke about RS VP and other all senior corporation programs that are beginning to require involvement in EBI classes. The AAA has asked members to continue to promote the program and assist the AAA in recruitment for program participation.

FY 19 Planning budget - Discussion of timeline push back, NFAs, & estimated submission date.

2018 Aging in Texas Conference - Held in Corpus Christi this year. Director Roberts was on the planning committee. Discussion of a training presentation on advisory committees that Director Roberts would like to present to RACOA at a future meeting.

Power in Community (PIC) Event - Distributed flyer amongst committee members. The event is to be held in CVCOG Training Room from 9am-3pm on August 29th, 2018. Mental Health First Aid will be the featured topic and will be presented by Catherine Hood with MHMR. Agenda to be completed & distributed by Friday. Media for this event will be in newspapers and on news stations. Recommendations were given by other members for additional advertising. Expecting at least 50 attendees.
