# APPROVAL of the prioritization of State Homeland Security Program grants as designated by the Emergency Preparedness Advisory Committee (EPAC)

Mattye Davenport, Homeland Security Planner, presented the prioritization of State Homeland Security Program grants as recommended by the Emergency Preparedness Advisory Committee (EPAC) for approval.

- 1. Concho Valley Council of Governments Regional Planning Project Recommended funding at 100% of \$134,042.04
- 2. City of San Angelo ST-CP TACMED Project Recommended funding at 65% of requested amount (\$57,985.07 of \$89,000) and up to 100% dependent on funding.
- 3. Tom Green County SRT Equipment Homeland Security Project Funded at 65% of requested amount (\$60,973.41 of \$93,586.74) and up to 100% dependent on funding.
- 4. Angelo State University Centennial Resident Hall Camera Project
  Prioritized as fourth but recommended for funding at 0% based on the national priority action areas unless specific funding becomes available from the Office of the Governor at a later date.

- c. John Austin Stokes, Executive Director, joined the meeting via Zoom from Washington, D.C. He and Judge Corbin were in Washington, D.C. to attend the National Association of Regional

Council (NARC) Conference. The NARC Conference is more comprehensive and includes topics on transportation, economic development, housing, and etc. Mr. Stokes learned of a couple of grant opportunities; one is from the EPA, for \$2 billion for tire clean up and the second is from the Department of Transportation (DOT); the DOT is offering a "Safe Cities" grant. Recently, Lubbock and Midland have secured \$1 million from the DOT grant for rural street projects. It was also stated that Tom Green County is currently working on a grant, and will collaborate with the COG, for a regional grant so that the grant application is more competitive. Lastly, Mr. Stokes and Judge Corbin were able to meet with Congressman Pfluger's office. Congressman Pfluger did submit, on our behalf, a Community Directive Spending Request and it was able to be added to the House budget. This request is for the remainder of the funding needed for our Transit Maintenance Facility.
